I wish to participate as a student volunteer (“Student”) in certain activities in connection with a musical theatre charitable project for the benefit of pediatric cancer research and awareness programs at Camp Ronald McDonald for Good Times and Children’s Hospital Los Angeles, which project is currently entitled “Sing!” (the “Project”). The activities in which I wish to participate are currently scheduled to take place on January 9, 16, 30 and 31, 2010 and on March 19 and 20, 2010 in Los Angeles, and may include one or more of the following: rehearsing, performing, creating and distributing invitations, programs and/or flyers, setting up snack and/or meal stations for cast and crew, assisting with backstage and/or red carpet press activities, general production assistance, director assistance and/or music director assistance. I understand that any and all of the activities I engage in on any or all of these dates shall be included in the term “Project.”

I understand that my participation in the Project is strictly voluntary and that I may discontinue my participation at any time. I understand that I am responsible for my own conduct and I agree to comply with any and all instructions of the Producer and its representatives. I understand and agree that, by participating in the Project, I am engaging in activities that may involve risk of injury up to and including death, which might result not only from my own action, inaction or negligence, but from the action, inaction or negligence of others or the conditions of the premises or of any equipment used. Further, there may be other risks that are not known or reasonably foreseeable at this time. Such risks may include, but are not limited to: the nature of the activity; latent or apparent defects or conditions in equipment or property used for the Project, acts or omissions of the Producer, or any of their volunteers, employees, agents, contractors, subcontractors, or representatives; my own physical condition; my own acts or omissions; and first aid emergency treatment. I freely assume all of these risks.

As consideration for being permitted to participate, I expressly agree and promise to accept and assume all risks that may arise in connection with my participation in the Project and agree not to sue and forever discharge Producer, its officers, employees, agents, contractors, subcontractors, representatives and the successors and assigns of each (collectively, the “Releasees”) of and from any and all claims (including for attorneys’ fees and costs), demands and causes of action, liability, damages and demands of any kind whatsoever, I have or might have against them or any of them, whether known or unknown, in law or equity, contract or tort, arising out of or in any way relating to my participation in the Project.

I understand that the Project will be recorded. For One Dollar (\$1.00) and for other good and valuable consideration, the adequacy and receipt of which hereby is acknowledged, I hereby irrevocably consent to be recorded in connection with the Project. I acknowledge and agree that I may be recorded by various means (including sound, still photography and digital photography), any/all of which shall be deemed part of the Recording. I irrevocably grant to Producer, its successors and assigns the right,

in perpetuity, throughout the universe, in all media now known or hereafter existing, in any language, to use my name, voice and likeness in the Recording and in connection with the advertising, promotion and exploitation of the Project.

I hereby waive any objections to any use made of the Recording, or any portion thereof, or of my name, likeness, voice, or of any interview given by me, in connection with the Project or any other production or advertising or publicity relating thereto, and I hold harmless, release and discharge Producer and Releasees from any and all claims, demands or causes of action that I may have now or in the future arising out of or in connection with the permission granted herein, including but not limited to any claims for libel, defamation, invasion of privacy and/or right of publicity. Without limiting the generality of the foregoing, I acknowledge that my consent includes permission to edit any part of the Recording. I also understand and agree that Producer is not obligated to use the Recording in any manner.

I understand and acknowledge that Producer will proceed with the Project and the Recording in full reliance on the above permission and release. This permission and release shall be binding upon my heirs, personal representatives, administrators, executors, and assigns.
